Patriots –Since 2005 over one rifle company has been lost to suicide. Let's put that in perspective, more than a rifle company over 200 Marines. That's a company of Marines that could have been fighting the enemy and killing the enemy, instead they took their own lives. For a period of time, here at Lejeune, every Battalion returning had a suicide. If you feel that you are having trouble coping, call the National Suicide Prevention Lifeline at 1-800-273-TALK (8255), a free, 24-hour hotline available to anyone in suicidal crisis or emotional distress. Don't be another non-combat statistic, life is too precious and you mean way too much to our chapter and your family.

PTSD Treatment Showing Promise. U-T San Diego A new experimental treatment for posttraumatic stress disorder (PTSD) involving 30 patients is taking place at the Naval Medical Center in San Diego. The treatment involves ganglion "stellate block [SGB] injections" to the neck to "numb nerves...that can cause physical arousal." Patients then feel calmer reported decreased symptoms. The "final results of the trial, which is ongoing, have not been determined."

USA Today "Eddie Ray Routh, an Iraq War veteran who has been charged in the killings of former Navy SEAL sniper Chris Kyle and another man at a Texas gun range, is widely reported to suffer from post-traumatic stress disorder," or PTSD. Sites points out that a "2009 study by the Department Veterans Affairs posits the concept of 'moral injury,' that guilt about killing or not being killed in war might truly be the instigator" for PTSD. Sites goes on to argue that "we must not default to a narrative of fear in which a veteran with PTSD equals a ticking time bomb."

GI Bill Offers Military Children Relief From College Costs.

Chronicle Of Higher Education "One of the most popular provisions associated with the Post-9/11 GI Bill" is the "option to transfer...benefits to a child or spouse." The "Department of Veterans Affairs has spent just shy of \$26-billion on the Post-9/11 GI Bill; over the program's life span, it is projected to cost \$90-billion. Given such investment, some educators have questioned whether the children of high-ranking officers in particular should benefit from the related Yellow Ribbon Program, which gives some GI Bill recipients even more aid-pledged by participating colleges and matched" by the Federal government.

MetroWest Daily News John O'Leary, who has been sober for 180 days, is "one of the 20 or so veterans" that Judge Mary Hogan Sullivan "regularly sees at the mandatory session for the Norfolk County Veterans Treatment Court. The court-supervised 12-to- 24-month program, the first of its kind in New England, serves veterans tied up in the criminal justice system because of their struggles with addiction and mental health issues." According to the Daily News, veterans courts "bring the Veterans Administration into the equation, ensuring each veteran receives the benefits he or she earned - ranging from mental health and substance abuse treatment, to housing, education and employment benefits."

Lawmakers introduce bill to demote Pentagon's new medal

The Distinguished Warfare Medal, which could go to servicemembers who never set foot in a combat zone, but launch drone strikes or cyberattacks that kill or disable an enemy.

WASHINGTON — Lawmakers are lashing out at the Pentagon's creation of the Distinguished Warfare Medal - intended to honor the contributions of drone pilots and cyber warriors who haven't set foot on the battlefield - by introducing legislation that would ban it from being rated on par with or above the Purple Heart.

A trio of veterans serving in Congress, Reps. Duncan Hunter, D-Calif., Tom Rooney, R- Fl., and Tim Murphy, R-Pa., introduced the bill on Wednesday, in response to what has been a public outcry against the creation of the medal, which was announced on Feb. 13.

"Combat valor awards have a deep and significant meaning to those who serve in America's military," said Hunter, a former Marine, in a statement. "These awards represent not just actions, but also the courage and sacrifice that derive from experiences while in harm's way. And those engaged in direct combat put their lives on the line, accepting extraordinary personal risk."

According to Pentagon officials, the medal, which ranks immediately below the Distinguished Flying Cross, was intended to recognize "extraordinary achievements that directly impact on combat operations, but do not involve acts of valor or physical risks that combat entails."

But that has led to public outrage over it from groups such as the Veterans of Foreign Wars and the Military Order of the Purple Heart, which have expressed fears that it cheapens the significance of other combat medals that are awarded at risk of physical harm, injury or loss of life.

Rooney, an Army veteran, urged the Pentagon to reconsider its ranking of the new medal, which would be ranked above the Bronze Star and Purple Heart, in a letter to military top brass earlier this month. And the number of petitions demanding a change have continued to grow online on the White House's "We the People" website. However, Pentagon officials have not said they would reconsider the medal's placement.

Rooney said in a statement on the new bill that he and other veterans "had grave concerns" about the ranking of the medal.

"There is no greater sacrifice than risking your own life to save another on the battlefield," he said, "and the order of precedence should appropriately reflect the reverence we hold for those willing to make that sacrifice."

Murphy, a Navy veteran, said he strongly believed from his personal experiences of serving with "combat-wounded veterans at Walter Reed (Army Medical Center), that their Purple Heart should and must rank above the Distinguished Warfare Medal."

"If the Pentagon will not reconsider the decision to rank this medal above the Purple Heart, the House will take action," he said.
