COVID-19 Vaccine Distributed in Phases to TRICARE Members

The COVID-19 vaccine will soon be available for you and your family. The Department of Defense (DoD), in collaboration with the Department of Health and Human Services and the Centers for Disease Control and Prevention, will provide COVID-19 vaccines in phases.

"As the vaccine becomes more widely available in the coming weeks, we strongly encourage everyone to get vaccinated," said Defense Health Agency Director Lt. Gen. (Dr.) Ronald J. Place. "The vaccine is safe, effective, and a critical addition to current public health measures. It helps us protect our health, our families, our communities, and significantly decrease the public health risks associated with the COVID-19 pandemic."

As this critical response begins, you may have questions about the COVID-19 vaccine, as well as when and how you can get it. **Who is getting the vaccine first?**

The first supply of the vaccine is limited. The DoD is prioritizing distributing vaccines to those providing direct medical care, maintaining essential installation functions, deploying forces, and those who are at the highest risk for developing severe illness from COVID-19. Once the initial phases of the vaccine distribution are complete, the vaccines will become available for other beneficiaries under the phased approach. Where can you get the vaccine when offered?

During the limited distribution phase, the vaccine is only available at certain locations throughout the U.S. and overseas. Once the initial phases of the vaccine distribution are completed, the vaccines will be more broadly available.

You'll eventually be able to get the vaccine at:

- Your local <u>military hospital or clinic</u>.
- Your civilian provider.
- TRICARE network pharmacies.

TRICARE is working to ensure you have no out-of-pocket costs.

Why should you get the vaccine? According to the <u>Centers for Disease Control</u> and Prevention, the COVID-19 vaccine is an important tool to help stop the pandemic. Getting the vaccine will lower your risk of contracting COVID-19 and may help keep you from getting seriously ill if you do get the virus. Getting vaccinated also protects the health of the people around you—especially those who are at increased risk of severe illness from COVID-19.

What can you do now?

Remember it's still important for you to follow COVID-19 safety procedures to help slow the spread of the virus. You should continue to <u>practice healthy habits</u>. These habits include wearing a mask, practicing physical distancing, restricting your movement, and washing your hands.

<u>VA to begin COVID-19</u> <u>vaccinations at 128 additional</u> <u>sites</u>

WASHINGTON — The Department of Veterans Affairs (VA) will begin COVID-19 vaccinations this week at 128 additional sites using the Moderna and Pfizer COVID-19 vaccines.

On December 18, the U.S. Food and Drug Administration (FDA) issued an Emergency Use Authorization of the Moderna COVID-19 vaccine, which is the second COVID-19 vaccine to be authorized.

"Having a second COVID-19 vaccine will enable us to reach more facilities and vaccinate more health care personnel and Veterans in additional parts of the country," said VA Secretary Robert L. Wilkie. "We continue to implement our COVID-19 Vaccine Distribution Plan and are grateful to be one step closer to seeing the end of this pandemic."

Per Centers for Disease Control and Prevention (CDC) recommendations, VA will continue to vaccinate health care personnel, as well as community living center and spinal cord unit residents. As vaccine supplies increase, VA's ultimate goal is to offer COVID-19 vaccinations to all Veterans and employees who want to be vaccinated.

The number is available 24 hours-a-day, 365 days-a-year to serve Veterans, their families, caregivers and survivors.

Responding to Veteran feedback on the challenges of knowing the right number for VA assistance, 1-800-MyVA411, serves all members of the Veteran community seeking information or

help. Veterans and their families can still reach the Veterans Crisis Line directly at 1-800-273-8255 and pressing 1, by Chat or by texting 838255. The White House VA Hotline is also still available at 1-855-948-2311 for Veterans and their families to share compliments and concerns.

"1-800-MyVA411 is always the right number to reach VA and is a great example of the department's customer service strategy in action," said VA Secretary Robert Wilkie. "1-800-MyVA411 provides easy access to specialized contact centers as well as an option to immediately talk to a live agent."

When dialing 1-800-MyVA411, callers have the option of pressing 0 to be immediately connected with a customer service agent to answer questions or provide a warm-handoff to the appropriate VA expert.

During the pilot phase from Oct. 1, 2019–Sep. 31, 1-800-MyVA411 connected more than 1.3 million callers with VA contact centers and experts.

A little on Flag etiquette

Many people love to display our National colors. Many don't know the rules involved in doing so. We are considered the duty experts on the flag, receiving phone calls at times with flag questions. When we go to events there's always someone there with the flag improperly displayed and we politely correct them. The biggest error is the placement of the flag on the wrong side.

Here are few basic guidelines to keep in mind based on the U.S. Flag Code:

- Always make sure the flag never touches the ground or anything below it.
- Do not display the American flag in inclement weather, unless it's an all-weather flag.
- If you want to fly the flag after sunset, keep it well lit.
- When you hang the flag vertically on a flat surface, make sure the Union (blue section) is on the observer's left.

Wondering what you should you do when your flag becomes worn and no longer suited for public display? The U.S. flag code requires it to be disposed of respectfully, preferably by burning. Many local VFW posts and American Legions hold ceremonies to retire flags if you do not feel comfortable doing it yourself.

As a symbol of the country and its people, the flag should be treated with respect and be honored when on display. In order to treat the flag with the dignity it deserves, the following display guidelines are recommended.

GENERAL GUIDELINES FOR DISPLAYING THE FLAG:

- When the flag is hung vertically on a wall, window, or door, the Union (blue section) should be to the observer's left. When the flag is hung either horizontally or vertically against a wall, the Union should be to the observer's left.
- In a procession, the American flag should be to the right (the flag's own right) of any other flag or, if in a line of other flags, in front of the center of that line.
- When displayed from a staff projecting from a building, the union should be at the peak of the staff.
- When the flag is displayed otherwise than by being flown from a staff, it should be displayed flat, whether indoors or out; or so suspended that its folds fall as freely as though the flag were staffed.
- When displayed over a street, the flag should be suspended vertically with the union to the north in an east and west street, or to the east in a north and south street.
- On a platform, the flag should be above and behind the speaker, with the union uppermost and to the observer's left.
- When displayed from a staff in a church or auditorium, the flag should occupy the position of honor and be placed at the speaker's right as he faces the audience.
- When the flag is used to cover a casket, the union should be at the head and over the left shoulder.

WHEN TO DISPLAY THE AMERICAN FLAG

The flag is a symbol of respect, honor, and patriotism. It may be displayed on any day of the year according to the following guidelines:

The flag should not be displayed on days when the weather is inclement.

The custom is to display the flag only from sunrise to sunset on flagstaffs in the open, but it may be displayed at night—if illuminated to produce a patriotic effect.

The flag should be displayed on all days, especially on:

New Year's Day, January 1 **Inauguration Day, January 20** Martin Luther King Jr.'s birthday, third **Monday in January** Lincoln's Birthday, February 12 Washington's Birthday, third Monday in February Easter Sunday (variable) Mother's Day, second Sunday in May Armed Forces Day, third Saturday in May Memorial Day (half-staff until noon), the last Monday in May Flag Day, June 14 Father's Day, third Sunday in June **Independence Day, July 4** Labor Day, first Monday in September **Constitution Day, September 17** Columbus Day, second Monday in October Navy Day, October 27 Veterans Day, November 11 Thanksgiving Day, fourth Thursday in November **Christmas Day, December 25** and such other days as may be proclaimed by the President of the United States the birthdays of States (date of admission) and on State holidays.

The flag should be displayed at every public institution and in or near every polling place on election days, and at schoolhouses during school days.

Note: Many of us fly ours 24/7
